Title	Honourary Road Renaming Proclamation
Proposed Motion	That Council proclaim Range Road 220 south, located south of Highway 643 and dead-ending at Township 560, as Dlouhy Road, to recognize the significant and long-standing contributions Mr. Garry Dlouhy has made to the Pembina Redwater Fractionation Site (RFS), the surrounding community and the Sturgeon County region.
Administrative Recommendation	Administration supports the honorary road renaming of Range Road 220 south as Dlouhy Road.

Report	<p><u>Background Information</u></p> <ul style="list-style-type: none"> • In March of 2018, Mr. Wayne Carey from Pembina RFS reached out to Sturgeon County to discuss the potential of renaming Range Road 220 south to Dlouhy Road, in honour of Mr. Garry Dlouhy. • Mr. Garry Dlouhy has been the Site Manager at the Pembina Redwater Facility for the past 45 years and is entering retirement in 2018. • Mr. Dlouhy has been instrumental in our community, supporting Sturgeon County in numerous community investment and community engagement activities. • Mr. Dlouhy has directed the facility through numerous stages of growth and development at Pembina RFS. • Under Mr. Dlouhy’s leadership onsite, Pembina RFS has grown to become the largest NGL facility in Canada and the fourth (4th) largest in North America. As a result, Pembina is one of the top five (5) developments in industrial assessment value and tax revenue in Sturgeon County. • The section of Range Road 220 proposed for renaming runs south of Highway 643 to Township Road 560. This road is used only by people accessing the Pembina and Inter Pipeline Facilities. It dead-ends at Township Road 560. • Honourary road naming does not actually change the road name. It basically adds an alternative name. There is no real impact to any stakeholder, other than having Sturgeon County Protective Services aware of the honorary name for reference.

	<p><u>External Communication</u></p> <ul style="list-style-type: none"> • Pembina and Sturgeon County will engage with and immediately notify affected landowners (ie: Pembina, Inter Pipeline, and Access Pipeline) along the approximate 2.5-kilometre stretch of Range Road 220 that will be renamed. • Sturgeon County will notify Alberta Transportation, Sturgeon County Protective Services and Sturgeon County Transportation. <p><u>Relevant Policy/Legislation/Practices:</u></p> <ul style="list-style-type: none"> • Part 58(1) of the <i>Municipal Government Act</i> states “a municipality may name roads or areas within its boundaries.” • There is no further specific protocol mandated. • Since we have no formal bylaw/policy/procedure to the contrary, if Sturgeon County and Pembina have done basic due diligence to contact key stakeholders, Council and Administration can make the decision to proceed with an honorary naming of the road.
<p>Implication of Administrative Recommendation</p>	<p><u>Strategic Alignment:</u></p> <ul style="list-style-type: none"> • Community Identity & Spirit – Renaming Range Road 220 south to Dlouhy Road in honour of Mr. Garry Dlouhy’s contributions to Sturgeon County and his 45 dedicated years of service to Pembina RFS and the region is in line with the County’s Strategic Goal 4.1 – Sturgeon County residents and stakeholders have a strong identity with the County and are proud to live here. <p><u>Organizational:</u></p> <ul style="list-style-type: none"> • Administration time to research road renaming protocols. • Administration time to notify Alberta Transportation, Sturgeon County Protective Services and Sturgeon County Transportation Services. • Administration time to prepare Request for Decision, Proclamation and present to Council. <p><u>Financial:</u></p> <ul style="list-style-type: none"> • Approximately \$150.00 to provide Mr. Dlouhy and Pembina with framed copies of the Proclamation and new “Dlouhy Road” signage.
<p>Alternatives Considered</p>	<p>That Council not proclaim Range Road 220 south as Dlouhy Road.</p>
<p>Implications of Alternatives</p>	<p><u>Strategic Alignment:</u></p> <ul style="list-style-type: none"> • Sturgeon County may be viewed as a municipality that does not value Community Identity and Spirit. • Sturgeon County residents and stakeholders may not hold a strong identity with the County and may not feel proud to live here.
