

**BY-LAW 1175/09**

**MORINVILLE MUNICIPAL SEED CLEANING CO-OP LIMITED LOAN**

**STURGEON COUNTY, MORINVILLE, ALBERTA**

A bylaw to authorize the Council of Sturgeon County to make a loan to the Morinville Municipal Seed Cleaning Co-op Limited, a non-profit organization, for the completion of capital upgrades.


**WHEREAS:**

Section 265 of the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000 provides that a municipal council, by bylaw may authorize the lending of money to a non-profit organization.

**NOW, THEREFORE, THE COUNCIL OF STURGEON COUNTY DULY ASSEMBLED, ENACTS AS FOLLOWS:**

1. Sturgeon County, in accordance with Section 265 of the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000, hereby lends to the Morinville Municipal Seed Cleaning Co-op Limited, the principal sum of \$150,000, to be re-paid in accordance with the terms and conditions generally described below:
  - a. The Morinville Municipal Seed Cleaning Co-op Limited, a non-profit organization, in the Province of Alberta proposes to undertake or has completed several capital upgrades
  - b. The Morinville Municipal Seed Cleaning Co-op Limited will repay indebtedness over a period of ten (10) years in semi-annual or annual installments, including interest at two (2) percent.
  - c. The estimated cost to complete the capital improvements at the Morinville Municipal Seed Cleaning Co-op Limited plant is \$60,000 for dust control cyclones, \$15,000 for Teflon for gravity tables, \$25,000 for south east door and \$50,000 for indent refurbishing and the total amount to be borrowed from Sturgeon County will be \$150,000.
  - d. Sturgeon County will source the money to be loaned from the County's general operating reserve.
2. The funds shall not be disbursed until the Morinville Municipal Seed Cleaning Co-op Limited's authorized officers have provided Sturgeon County with a promissory note.
3. This bylaw comes into force on the date it is passed.
