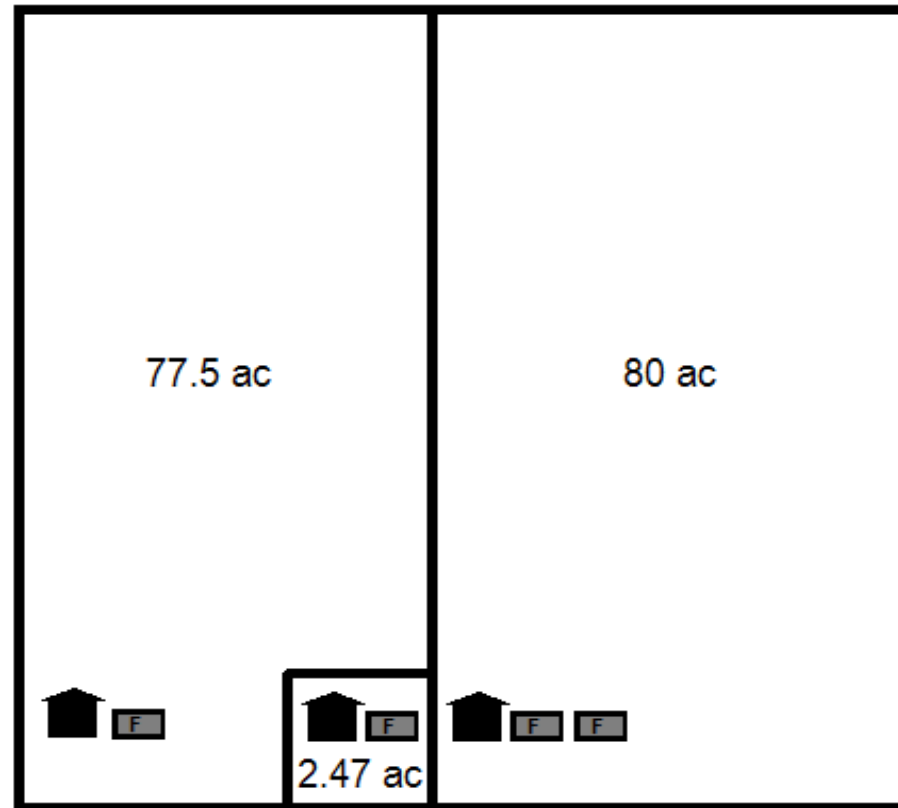


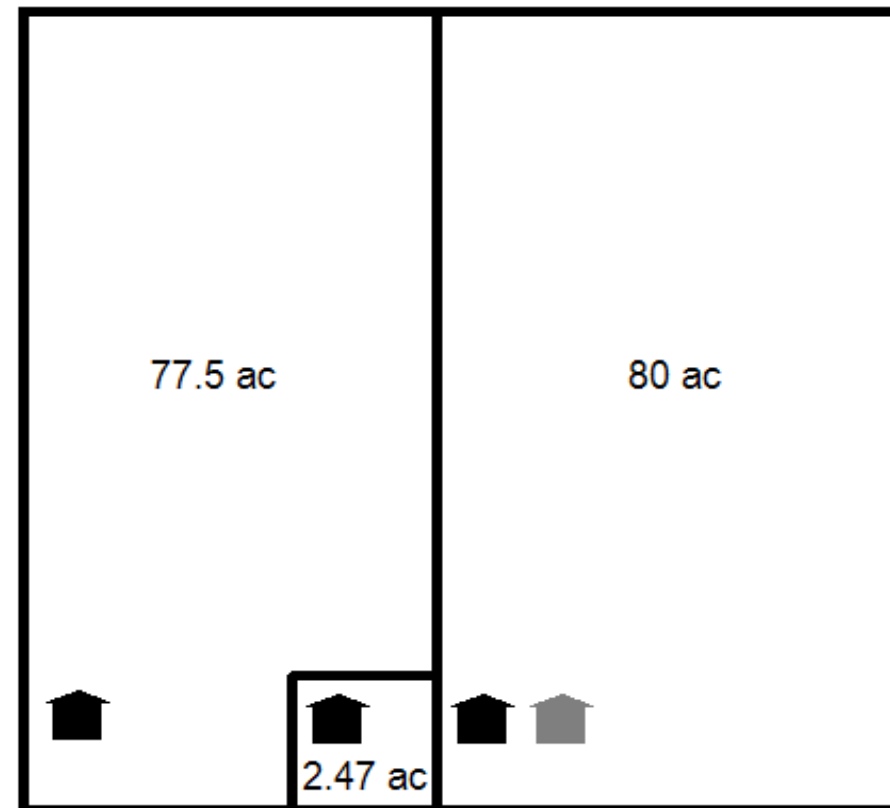

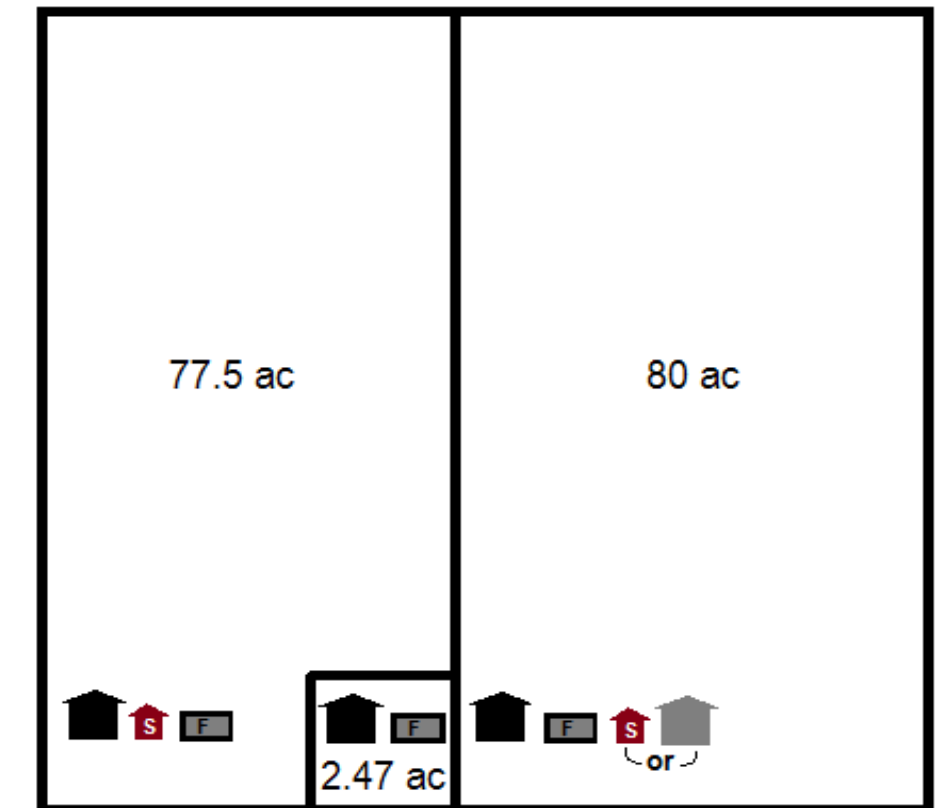
Note: a "Secondary Dwelling" entails a permanent house for any purpose/occupant. "Farm Help Accomodation" enables farm worker housing.
