Subject: Public Engagement on Bill 6: Enhanced Protection for Farm and Ranch Workers Act Regulations

Minister Carlier:

Sturgeon County Council is appreciative of the Ministry's commitment to public engagement and stakeholder input regarding the Regulations associated with the *Enhanced Protection for Farm and Ranch Workers Act*; our own Councillor Karen Shaw was a participant on one of the six Technical Working Groups over the past several months.

While Sturgeon County recognizes that the Enhanced Protection for Farm and Ranch Workers Act serves an important purpose in ensuring that agricultural workers have the same rights and protections as other workers in Alberta, it is important that this legislation and its associated regulations do not unfairly compromise the ability of agricultural producers to operate sustainably.

Further, given that the Legislative Assembly has approved *Bill 17: The Fair and Family-Friendly Workplace Act*, whereby it is understood that this legislation will have impacts on agriculture workers, and that public consultation was limited to a 36-day online feedback process, Sturgeon County Council, in coordination with the Sturgeon County Agriculture Service Board, requests that the Ministry of Agriculture and Forestry, in collaboration with the Ministry of Labour, conduct a broader engagement and communications exercise so that agriculture producers and workers are more aware of potential impacts of Bill 6 itself, the associated regulations, and any further anticipated impacts associated with Bill 17.

Without a thorough understanding of farmworker legislation, agriculture producers and workers are challenged to understand how their businesses, families, and livelihoods are impacted; without this awareness, any operational changes necessary to ensure legislative compliance may be inadvertently difficult.

As you are aware, agriculture is an integral part of Alberta's economy and Albertans' way of life. Misinformation and lack of certainty regarding legislative requirements make it challenging to make informed business decisions, and although the Government's public consultation process to-date has been
