Report	<p><u>Background Information</u></p> <ul style="list-style-type: none"> Under the <i>Municipal Government Act</i> (MGA), Assessment Review Board (ARB) members and ARB clerks must be appointed by Council and both ARB members and ARB clerks must meet training requirements set by the Minister.
