IMP Consultation Report

September 2019

This report sets out:

- The steps taken to publicize and engage with various key stakeholders, such as elected officials, key industry, developers with an interest locally and the community throughout the IMP preparation process;
- The main issues raised during the interview/questionnaire stage and how these inputs have influenced the preparation of the IMP.

The key principles that have underpinned engagement in the IMP process are:

- Creating the conditions for early involvement and feedback at a stage when consultation can recognize a chance to influence the development of the IMP;
- Encouraging the commitment of all participants to share their subject area expertise, future aspirations and industry specific knowledge;
- Using appropriate methods to enable participation, in addition to methods which facilitate appropriate, valuable input into the IMP development process

Introduction to the IMP

In April 2018, Sturgeon County initiated the preparation of a long range Infrastructure Master Plan (IMP) to help guide future decision making involving key infrastructure requirements. The focus of the IMP is to identify strategic infrastructure to support the County's long term development vision, with a focus on linear transportation, water, wastewater and stormwater infrastructure. The IMP development process included: 1) Assessing current infrastructure; 2) Evaluating key influencing trends/drivers; 3) Developing population/employment/land development scenarios and; 4) Consulting with key stakeholders in order to provide further insights towards future scenario analysis.

Consultation methods: Departmental/Staff

A technical working group was set up by the Planning and Regional Services (PaRS) team in order to ensure internal subject matter expert input into the IMP. The technical working group included Sturgeon County representatives from utilities, transportation, current planning and engineering. The team was involved through formal technical working group meetings, informal topic specific meetings, as well as numerous emails asking for input on draft deliverables, technical matters, etc. The Economic Development department was also consulted and provided key insights into long term growth potential for the Alberta Industrial Heartland and Sturgeon Industrial Park. They were also kept up to date with the progress of the IMP.

The Agriculture Services and Economic Development Boards were given a presentation on the scope and content of the IMP from the PaRS team and were given the opportunity to ask questions/provide any input into the IMP process.

The Sturgeon County Senior Leadership Team (SLT) were also updated and received a formal presentation on the final draft of the IMP from ISL on June 17th 2019.

Consultation methods: Elected Officials

Consultation methods: Industry and Developers

Key stakeholders (listed in Appendix 1: Key stakeholder list) within the business community were initially identified and consulted for their input into the IMP. Over half of those organizations identified provided input into the IMP's development. The consultation aimed to identify any future development plans, as well as discussing any issues/concerns, future needs, or trends that may affect infrastructure. Interviews (in person or on the telephone) were conducted, with email questionnaires (see Appendix 3: Questionnaire) offered to those who preferred that method of engagement. The questionnaire was used as the format for all interviews.

Key stakeholders provided a variety of input/feedback that ultimately influenced the development of the IMP including:

- Plans for proposed future expansions (location/timing) or land acquisitions;
- Infrastructure concerns including traffic and fire protection, among others;
- Highlighting best practice/potential technological/process enhancements that would reduce the need for water/sewage/stormwater infrastructure.

Sturgeon County Infrastructure Master Plan Stakeholder Information & Questionnaire October 2018

Background

Sturgeon County is currently developing a long-range Infrastructure Master Plan (IMP) focusing on transportation, water, wastewater and stormwater infrastructure to meet future needs. The IMP will be integrated with other local and regional growth frameworks and provide direction on the infrastructure required to accommodate future growth. The IMP will benefit Sturgeon County in terms of long-range capital prioritization/planning and also provide greater certainty for the development community as part of any investment decision making process.

Current Status

The IMP is underway and the assessment of existing infrastructure is nearing completion. The next phase of the study will consider the types of transportation, water, wastewater and stormwater investment that will be needed to accommodate residential and non-residential growth in the County.

At this time, the County is seeking input from development and industry representatives and other key stakeholders. This input includes development plans and priorities, obstacles to development, and any infrastructure requirements specific to proposed developments or to a particular industry.
