BY-LAW 929/02

CONSOLIDATION BYLAW

STURGEON COUNTY, MORINVILLE, ALBERTA

BEING A BYLAW OF STURGEON COUNTY, IN THE PROVINCE OF ALBERTA, TO ALLOW THE CONSOLIDATION OF STURGEON COUNTY BYLAWS.

WHEREAS Section 69 of the MUNICIPAL GOVERNMENT ACT authorizes Council to pass a bylaw authorizing the consolidation of bylaws of Sturgeon County; and

NOW THEREFORE the Council of Sturgeon County, in the Province of Alberta, enacts as follows:

ENACTMENT

1. This bylaw may be cited as the "Consolidation Bylaw".

DEFINITIONS

- 2. Words importing the masculine gender only, include the feminine gender whenever the context so requires and vice versa.
- 3. Words importing the singular shall include the plural or vice versa whenever the context so requires.
- 4. The County Commissioner or his delegate is authorized to consolidate the following bylaws and all amendments thereto, including the omission of any bylaw provision repealed or expired;
 - a) Sturgeon County Municipal Development Plan Bylaw 818/96
 - b) Sturgeon County Land Use Bylaw 819/96
 - b) Sturgeon County and City of St Albert Intermunicipal Development Plan Bylaw 906/01
 - d) Legal Crossroads Area Structure Plan Bylaw 907/01
 - e) Calahoo-Villeneuve Sand and Gravel Extraction Area Structure Plan Bylaw 922/01
 - f) Sturgeon Valley Area Structure Plan Bylaw 882/99
 - g) Alberta's Industrial Heartland Area Structure Plan Bylaw 900/00
- 5. The consolidation shall occur annually, in January, and include all of the amendments made in the prior calendar year to the above listed bylaws.
- 6. The bylaws consolidated under this Bylaw shall be designated as consolidated bylaws. The designation shall identify the date the consolidation was completed.

7. This bylaw comes into effect on the date of final passing.
