

- Trail Guidelines








Open Space Plan Recommendations

- County Wide Parks
 - Update Master Plans
 - Implement phased Master Plan actions, specifically surrounding the Sturgeon Valley Master Plan & Cardiff Park Rehab, & Improvement Strategy
- Neighbourhood Parks
 - Develop inventory and implement recommendations on a multi year approach.
- Local Open Space
 - Evaluate existing parcels for alternative use/acquisition/disposition

Priority Actions – Motion Considerations



- That Council direct Administration to bring forward Open Space projects that could be advanced in 2021, not to exceed \$500,000, at the June 8, 2021 Council meeting.
 - That Council direct Administration to
 bring forward an enhanced 5-Year
 Capital Plan surrounding Open Space
 Management by Q3 2021, based on
 Council's priorities for Budget 2022
 deliberations.



Budget 2021



- Budget 2021 allocated funds to the following projects
 - Glory Hills Playground
 - Cardiff Park Improvements:
 - Winter Skating Ribbon; pave Red Ribbon Trail; parking lot, enhance naturalization plantings; day use picnic sites;& fishing dock
 - Sturgeon Valley Trail Gap Analysis Trail Connectivity
 - Sandy Lake Environmental Assessment for potential staging
 - Redwater Assessment for potential staging
 - Pinewood Trail coordination
 - Temple Trail (Deferred)
 - Park site improvements for consideration in Crestview, Upper & Lower Manor, Bristol Oaks, Alcomdale, Villeneuve trails, and HOA partnerships in Hu Haven and Pinewood
