Dear Mr. Yanew:

Bids for the Villeneuve Airport Waterline Extension project were received through the Bids and Tenders website at 3:00 pm on Thursday, May 20, 2021.

Nine (9) bids were received for this Tender. The arithmetic has been checked on all bids. A summary of bids received are shown in **Table 1** below.

The attached **Table 2** summarizes the required submission documents included by the bidders. All bidders provided all required documentation. A complete bid analysis, including the breakdown of bid items, unit prices and extensions is attached in **Table 3**.

The lowest compliant bid was submitted by Syn Core Directional Ltd. (Syn Core). Syn Core is based and operated out of Coalhurst, Alberta with operations primarily consisting of directional drilling, excavating, air hammering, auguring, plowing and hydrovac services.

Associated Engineering does not have experience working with Syn Core. Associated Engineering contacted references supplied in the bid documents for previous projects of similar scope complete by Syn Core. References, including the Town of Magrath and the County of Lethbridge Rural Water Association, provided positive feedback regarding schedule, budget, site cleanliness, and overall work relationship.

The schedule provided by Syn Core demonstrates completion of works within the specified October 15, 2021 completion date. The schedule is attached and summarized as follows:

•	Mobilization	10 Days
•	Pipe Fusing and Installation	45 Days
•	Meter Chamber Installation	2 Days
•	Commissioning	7 Days
•	Demobilization	7 Days

Based on our review of the bids and analysis as outlined above, we recommend that Sturgeon County award the Villeneuve Airport Waterline Extension project to Syn Core Directional Ltd. at the Bid price of \$756,905.00. We recommend that Sturgeon County retain 20% as construction contingency and add a \$200,000 Provision Sum for Facility Upgrades for a total construction budget of \$1,108,286.00 as shown in Table 4 below.
